OH monthly maintenance fee	\$465 payable by the 10 th of each month (2025 rate).
Maintenance fee payments	Preferred to set up autopay with your bank. Mail payments to Charlotte Square office, 2296 Aaron St, Pt. Charlotte 33952 Alternative payment options available.
Proof of insurance	Building insurance renews Feb 01 yearly and is part of maintenance fees. Building insurance covers the structure of the building up to the taped and floated drywall, bare sheetrock ceilings and concrete floors. NOTE: Each owner must purchase condo insurance (H06 or equal) and liability insurance (\$300K) separately.
Association fee covers	Amenity upkeep, common area grounds maintenance, common areas, building insurance, common area electric, water and reserve funds required by law.
Charlotte Square community recreation facilities	Two pools, bath house, recreation hall, tennis and pickleball, shuffleboard, bocce ball, billiard / ping-pong.
Oxford House Amenities	Management Company (PPM), Board of Directors, 2 nd floor social room, coin operated laundry machines, 1 st floor office, secure entry system, storage lockers, bike storage rooms, luggage rooms, website, monitored fire alarm, and camera security system.
